Dear Chief Secretary/Administrator,

As you are aware, the Ministry of Women and Child Development (MWCD) is implementing a Centrally Sponsored Scheme namely 'Mission Vatsalya' through the State Governments/ UT Administration on a pre-defined cost sharing pattern. Mission Vatsalya Scheme along with the Juvenile Justice (Care and Protection of Children) Act, 2015 (JJ Act) and the Protection of Children from Sexual Offences Act, 2012 form the basic framework for ensuring security, dignity and well-being of vulnerable children especially Children in Need of Care and Protection (CNCP) and Children in Conflict with Law (CCL).

2. State Governments and UTs alongwith the District Magistrate / District Collectors have adequate legal and administrative powers to ensure that all the child care institutions as well as statutory structures like Child Welfare Committees (CWCs), District Child Protection Units (DCPUs) and Juvenile Justice Boards (JJBs) are functioning as per the specific provisions of the JJ Act and Rules made thereunder. All these specialized statutory bodies like CWCs, JJ Boards, DCPUs and Specialized Adoption Agencies (SAA) have to be manned effectively and properly by trained manpower to discharge their duties with sensitivity, empathy and in the manner given under the law. However, vacant positions of staff render these bodies ineffective ultimately leading to lack of protection and care for vulnerable children. List of such vacant positions of these statutory bodies in your State/UTs is annexed.

3. Given the above situation I would request your personal attention to communicate specific directions to the authorities concerned to fill up these State and District level positions urgently.
